TO THE HONORABLE BOARD OF COMMISSIONERS OF BERRIEN COUNTY: Your County Personnel and Human Services Committee respectfully recommends the adoption of the following:

RESOLUTION

WHEREAS, the Board of Commissioner has the responsibility to approve changes to the salaries of the six County-wide Elected Officials and for the Board itself in one salary schedule; and

WHEREAS, the current salary schedule expires on December 31, 2022; and

WHEREAS, the filing deadline for office of County Commissioner is April 19, 2022; and

WHEREAS, it is appropriate to finalize the salaries for FY2023 and 2024; and

WHEREAS, consistent with the approved non-union and appointed salary schedule for 2022, the recommendation of the Personnel and Human Services Committee is to increase the elected Official and Board of Commissioner salary schedule by two and a half percent (2.5%) effective January 1, 2023 and by two and a half percent (2.5%) effective January 1, 2024.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Berrien County Board of Commissioners approves the salary schedule for Elected Officials and Commissioners for the years of 2023-2024.
