The Day of Review of Apportionments is an opportunity to review the apportionment of benefit for the Drains listed in the above chart with the Drain Commissioner or a staff member.

The Drain Commissioner, engineers, and/or other staff members will be available to assist individuals throughout the day, and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Drain Commissioner's Office at the number listed above or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

You may appeal the Drain Commissioner's decision to revise the district boundary to the Berrien County Circuit Court within ten (10) days, and you may also appeal the determination of apportionments to the Berrien County Probate Court within ten (10) days.
