RESOLUTION

WHEREAS, the Michigan Department of Health and Human Services (MDHHS) desires to enter into a contract titled the Comprehensive Agreement for the fiscal year 2022-2023 (October 1, 2022 to September 30, 2023) in the amount of \$3,150,307 with the Berrien County Health Department (BCHD) to provide health services in accordance with the Michigan Public Health Code (P.A. 368 of 1978, as amended) for the residents of Berrien County; and

WHEREAS, this agreement ensures the provision of public health services in accordance with the Michigan Public Health Code (P.A. 368 of 1978) and MDHHS policies and protocols; and

WHEREAS, MDHHS requires the Agreement, if accepted, be executed through the authorized electronic signature of BCHD; and


WHEREAS, the Board of Health endorses the acceptance of this agreement.






