**RESOLUTION**

**WHEREAS**, the Michigan Department of Health and Human Services (MDHHS) desires to enter into a contract titled the Comprehensive Agreement for the fiscal year 2021-2022 (October 1, 2021 to September 30, 2022) in the amount of \$3,265,160 with the Berrien County Health Department (BCHD) to provide health services in accordance with the Michigan Public Health Code (P.A. 368 of 1978, as amended) for the residents of Berrien County; and

**WHEREAS**, this agreement ensures the provision of public health services in accordance with the Michigan Public Health Code (P.A. 368 of 1978) and MDHHS policies and protocols; and




