Back to School and COVID-19 Update - Health Officer Courtney Davis

Health Officer Davis presented a PowerPoint presentation:

COVID-19 Response Goals

- To decrease the transmission of COVID-19 in Berrien County and to protect our most vulnerable residents from undue illness and death;
- To protect the capacity of our local health system to ensure that they can safely provide health care to all residents in need; and
- To support and promote the overall physical, mental and emotional health of all community members and pandemic response partners.

Return to Learn for 2021-2022 School Year

- Whereas in-person learning has been shown to provide the greatest benefit to community youth, and where ensuring this can happen consistently and safely during the upcoming school year has been deemed a priority of public health and education partners.
- Through an ongoing partnership of public health and education partners, the
 following guidance is meant to support school districts in planning for a
 successful return to the classroom this fall and to ensure that COVID-19
 prevention and mitigation measures are implemented in a way that fosters
 optimal learning environments while simultaneously ensuring health and safety
 for the overreaching school-district community (students and staff alike).
- Local public health will provide ongoing monitoring of community transmission in Berrien County and the surrounding region. This activity will allow the Berrien County Health Department to support school superintendents and administrators in making informed and educated decisions that are best for school operations, students and staff. BCHD will provide updates and adjust recommendations based on the CDC's predesignated indicators and thresholds for community transmission of COVID-19.
