The Berrien County Drain Commissioner will meet on the above date, time, and location to receive construction bids for the Kelly Drain. Bids will then be opened and publicly announced.

Bids will be received for the construction of the Kelly Drain project with the following approximate quantities and appurtenances:

*Installation of approximately 1,050 feet of 18" storm sewer, 226 feet of 15" storm sewer, and 30 feet of 12" storm sewer with an average depth of 5 feet. Also includes the installation of 3 culverts (see below) and 350 feet of open channel clean-out. Project also includes road restoration.*

*Crossing information:*

*No. 1 – Sta 0+22 – Road Crossing – Shoreview Drive – 52 feet 60" C.M.P. Culvert*

*No 2 – Sta 3+11 – Private Crossing – Hrody, C – 80 feet 36" Dual-Wall H.D.P.E. Culvert*

*No 3 – Sta 3+67 – Private Crossing – Rodriguez, A – 20 feet 36" Dual-Wall H.D.P.E. Culvert*

This Notice of Letting, the plans, specifications and bid proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents now on file at the Berrien County Drain Commissioner's Office and available to interested parties. Bids will be made and received in accordance with these documents. Bidding Documents, including plans and specifications, may be examined at the following locations:

A **mandatory** pre-bid conference will be held on Wednesday, August 10, 2022 at 10:00 a.m. at the Berrien County Drain Commissioner's Office, 701 Main Street, St. Joseph, Michigan 49085.

A security deposit in the amount 5% of the total bid shall be submitted in the form of a cashier's check, money order, certified check or bidders bond with any bid. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and

to adjourn to a time and location as we shall announce.

Bids will be accepted at the Berrien County Drain Commissioner's Office located at 701 Main Street, St. Joseph, Michigan 49085. **All bids must be received prior to 10:00 a.m. on Tuesday, August 23, 2022.**
